**Operation Type of Inspection Body:**

ISO/IEC 17020, Conformity assessment — Requirements for the operation of various types of bodies performing inspection, Annex A Independence requirements for inspection bodies, Type C most closely resembles the operation type operated by this organization. The inspection body shall provide safeguards within the organization to ensure adequate segregation of responsibilities and accountabilities between inspection and other activities; the design/manufacture/supply/installation/servicing/maintenance and the inspection of the same item carried out by a Type C inspection body shall not be undertaken by the same person. An exception to this is where a regulatory requirement explicitly allows an individual person from a

Type C inspection body to undertake both the design, manufacture, supply, installation, servicing, maintenance and the inspection of the same item, as long as this exception does not compromise the inspection results.
